### Text Messaging (SMS) Terms and Conditions


**Program description:** You choose to consent to receive text messages from Northwest ADHD Treatment Center when completing the Informed Consent document. This document is required to be completed prior to your first appointment. When opted-in, you will receive text messages (SMS/MMS) to your mobile number. These kinds of messages may include a response to an inquiry, real-time texts to ask and answer questions about our billing services, and appointment confirmations and appointment reminders. Message frequency varies. This is a brief description of the kinds of messages users can expect to receive when they opt in.

**Opt-out:** You can cancel the SMS service at any time. **Just reply back with STOP.** Our billing service messages and appointment reminder services are separate. If you wish to cancel SMS services for billing, reply STOP to a billing related message. If you wish to cancel appointment reminders, you must reply stop to an appointment reminder message. You cannot cancel both services with one message. After you send the SMS message STOP to us, we will send you an SMS message to confirm that you have been unsubscribed. After this, you will no longer receive SMS messages from us for the service type you have chosen to opt out of. If you want to join again, please contact our office at (503) 255-2343..



## Northwest ADHD Treatment Center Website Terms and Conditions




